<sup>2)</sup> If case administration is required, an hourly rate or part thereof will be charged.

- 3) NB: A fee of EUR 35 (DKK 260) shall be charged for countries where the European Commission has concluded, or is negotiating a visa facilitation agreement.
- 4) No fee shall be charged for applications regarding the naturalisation of children below the age of 18 provided the parents - or one of these - were born Danish or have subsequently obtained Danish nationality.
- 5) Where several documents are issued at the same time, a total fee of DKK 195 shall be charged.
- 6) Provided the request for VAT refund comprises several separate purchases, a fee of DKK 195 shall be charged per statement.
- 7) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 3,905 shall be charged for the first passport and DKK 960 for subsequent passports.
- 8) Where several provisional passports or extension of passports are issued at the same time, a fee of DKK 5,580 shall be charged for the first passport and DKK 960 for subsequent passports.
